O F F I C I A L R U L E S F O R T H E HOUSE OF JERKY ADVENTURE BAG SWEEPSTAKES

No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- 1. Eligibility: The House of Jerky Adventure Bag Sweepstakes (the "Sweepstakes") is open to legal residents of the United States who are at least eighteen (18) years old.
